#### 1. Plan aims

The Brian Clarke CE Academy is an inclusive school which aims to give every student the opportunity to access a full and broad curriculum and feel valued and included within the school community. We aim to treat all of our students fairly and with respect. This involves providing access and opportunities to all, without discrimination of any kind.

The plan is published on the school website. Paper copies are available on request.

We are committed to actively promoting equal opportunities to all staff and students.

This document meets the requirements of schedule 10 of the <u>Equality Act 2010</u> and the Department for Education (DfE) <u>guidance for schools on the Equality Act 2010</u>.

The Equality Act 2010 defines an individual as disabled if they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to undertake normal day to day activities. Under the <a href="Special Educational Needs and Disability">Special Educational Needs and Disability</a> (SEND) Code of Practice, long-term is defined as 'a year or more' and substantial is defined as 'more than minor or trivial'. The definition includes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make reasonable adjustments for pupils with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a disabled pupil faces in comparison with non-disabled pupils.

#### 2. The principles that underpin this plan

In line with the Equality Act 2010 the aims of this policy are to:

- Ensure all students, including those with a disability as defined within the Equality Act, have access to a full and broad curriculum
- Ensure that reasonable and suitable adjustments are made to the physical environment to ensure students with a disability can participate fully in school life
- Respond to individual student need to make suitable adaptations to the physical environment
- Overcome potential barriers to learning and assessment for students with a physical or learning disability

#### 3. Reasonable Adjustments

We are committed to reasonable adjustments as summarised in the Equality Act:

- Where something the school does places a disabled pupil at a disadvantage compared to other pupils then the school must take reasonable steps to try and avoid that disadvantage
- Schools will be expected to provide an auxiliary aid or service for a disabled pupil when it would be reasonable to do so and if such an aid would alleviate any substantial disadvantage that the pupil faces in comparison to non-disabled pupils
- We are committed to making reasonable adjustments for students with physical disabilities and learning disabilities

#### 4. Complaints
